## TERMS & CONDITIONS GOVERNING THE APPOINTMENT OF OUTSTANDING SCIENTIST (STIO) IN CSIR

- The appointment is as Outstanding Scientist (STIO) with pay equal at present to Additional Secretary level post under the Council of Scientific and Industrial Research, which is an autonomous body under the Ministry of Science & Technology, Deptt. of Scientific and Industrial Research (a Society registered under the Societies Registration Act).
- The appointment as Outstanding Scientist(STIO) will be on ad-hoc/contract basis for a period of one year.
- 3. The scale of pay attached to the post of Outstanding Scientist/Technologist is Rs. 37,400-67,000 in Pay Band-4 with a Grade Pay of Rs. 12,000/-. In addition, he/she shall be eligible to receive others allowances, as applicable to CSIR employees, at the rate in force from time to time.
- Your appointment will be subject to the production of medical certificate of health and physical fitness for service from a Medical Board/Hospital and verification of character & antecedents.
- You will be liable for transfer to any of the establishments under the administrative control of the Council anywhere in India.
- 6. If married, you will be required to sign a declaration that you have not more than one living spouse and if unmarried you will not marry a second time while your first spouse is alive save with the permission of competent authority. You will also have to sign a declaration that you will not marry any person who has a spouse living without permission of the competent authority.

He/she shall assign the inventions and improvements from CSIR/Gol funded research and execute all documents necessary to vest the invention in any person appointed by the Council in its absolute discretion.
